# Proposition 1

Prop 1 would draw down property taxes for elderly and disabled Texans by reducing the amount they pay to public schools, which typically makes up most of a homeowner's tax bill. The state would then cover that reduced revenue for school districts. The measure would cost the state more than \$744 million from 2024 to 2026.

# **Proposition** 2 (vote yes or no)

Prop 2 would raise Texas' homestead exemption from \$25,000 to \$40,000 for school district property taxes, which would save the average homeowner about \$176 on their annual property tax bill. If approved, this measure would cost the state \$600 million annually. The state will use a \$4.4 billion surplus to pay for the measure's first-year cost, but as of October, it was unclear where future funding would come from.

#### WHO AM I ELECTING?

The mayor and city council or board of aldermen collectively serve as the governing body for a city and normally possess all legislative powers granted by state law. The positions of both councilmember and alderman have been compared to those of the members of the state legislature and the United States Congress. All these positions require elected officials to represent their constituents, to make policy decisions, to budget for the execution of the policies, and to see that their policies are carried out. Unlike their counterparts in state and federal offices, however, city officials are in direct contact with the citizens they serve on an ongoing basis.

#### WHAT IS A BOARD OF TRUSTEES?

The main function of the school board is to provide local, citizen governance and oversight of education. Though ultimate responsibility for education rests with the state, Texas has delegated much of the authority to local communities who elect their local school trustees to govern the school district.
